### Board Meeting July 13, 2021

The meeting was called to order by Chair Jennifer Meyer. People in attendance were: Supervisors – Jeff Whyte, Mona Mathews, Jeff Bechard, Paul Travis, Clerk Beverly Christopherson, and see attached list of visitors. Treasurer John McLaughlin not in attendance.

# **Comp Plan:**

- A. Eau Claire Coop Oil/Conditional Use Permit Application to amend previous CUP, dated 08/18/2020 and incorporate a 60x125x16 or 7500 sq, ft. truck port/Joe Alf. Joe Alf was present to answer any questions. This is not an enclosed building as LP Truck kept inside. Supervisor Jeff Bechard made a motion to approve the CUP for Eau Claire Coop Oil. Supervisor Mona Mathews seconded the motion. All voted yes, motion carries.
- **B.** JR Rental Properties/Rezone .72 acres from RH to C3/Real Land Surveying (RLS) Jeremy Skaw. This rezone is for .72 acres to make it a conforming lot. Well and Septic are no longer on the lot. Town of Union Comp Plan reviewed and spoke with Owner and Surveyor. Town did receive a few concerns from residents on problems that could arise. Chair Jennifer Meyer mentioned that at this time the Town is just looking at the re-zone so, the Town is not able to address the concerns. Any concerns that are opposing the re-zoning can be addressed at this time. The main lot is already zoned C3 except for this small area.

Supervisor Mona Mathews made a motion to approve the rezone of .72 acres from RH to C3. Supervisor Jeff Whyte seconded the motion. All voted yes, motion carries. Supervisor Jeff Bechard just wanted clarification that residents who had issues were on Lot 1. Chair Jennifer Meyer said That is correct. All voted yes, motion carries.

C. JR Rental Properties/Certified Survey Map (CSM) lot configuration /RLS Jeremy Skaw. This is just for informational purposes, no motion needed.

## West Wisconsin Telcom-24/7 Broadband "Fiber to the Home Project" American Rescue Plan Act

(ARPA) grant money request – West Wisconsin Telcom requested to be on the Agenda regarding the ARPA Grant money. Jim Kusielek from 24/7 Telcom was present to explain what West Wisconsin Telcom would be able to do for the Town regarding Broadband. West Wisconsin mentioned that from County E & EE to the Southwest seems to be the area in need of broadband. West Wisconsin would put the broadband in to the resident's home. Cost for this is approximately \$821K. Town ARPA grant would not cover all this cost but Town only has to use the Grant money.

Supervisor Mona Mathews would like to have more information on how many homes don't have broadband. Supervisor Jeff Bechard would like more factual information before the Town makes a resolution to give West Wisconsin the ARPA Grant funds. Town Board would like to table till more information is available.

Chair Jennifer Meyer will put back on the agenda for August to get more information on the ARPA Grant and how it can be spent.

**Cedar Corp Presentation/Proposal County Line Rd:** Dennis Mack and Russ Kivinnenri were here from Cedar Corp and handed out a packet explaining who Cedar Corp was. Cedar Corp is helping the

Town with County Line Road. County Line Road should be designed for a Truck Route. Funding for this project would come from Grants. First step is to do some preliminary surveying and planning. Supervisor Mona Mathews made a motion to approve Cedar Corp to start preliminary surveying and concept planning estimate for the Town on cost to start. Supervisor Jeff Whyte seconded the motion.

#### **Park Commission:**

A. Chair Report/Barb Kleist filling in for Fred Belay: Barb Kleist mentioned that the Park Commission is working on the Pavilion for the Conservancy and waiting on permits from Eau Claire County. Park Commission is having Tru Lock install cameras in the Conservancy due to vandalism. Cost is \$9,264.00 and a deposit of \$5,000.00 is due at this time. In the Fall the Park Commission is planning another invasive & native species event. Park Commission is looking into the Ball Fields.

### Visit Eau Claire:

**A.** Executive Director Benny Anderson Report: Benny Anderson was present and reported to the Town Board that room tax for 2021 is only down 9% at 1<sup>st</sup> quarter. Destination Development money for the Town of Union should be around \$15,000 is room tax dollars stay around the same for 2021.

### **Township Fire Station #3:**

**A.** Battalion Chief Report: Battalion Chief Dave Kleist in attendance: Township Fire is in need of volunteers. Awards Banquet will be coming up on August 27 at 5pm. Farm Tech Days will be next week.

### Eau Claire County Tax Deed(s) sale for discussion:

A. Property adjacent to Sherman Creek Park: Chair Jennifer Meyer did bring this up at the Park Commission meeting. This land has been offered to the Town before and was turned down as this parcel is land locked between Sherman Creek Park and Judy Bechard. Supervisor Jeff Bechard mentioned that transients have lived in this area before as the land is not fenced in.

Supervisor Mona Mathews made a motion "Not" to approve the purchase of this land. Chair Jennifer Meyer seconded the motion. Supervisor Jeff Whyte voted yes, Supervisor Paul Travis voted yes, and Supervisor Jeff Bechard abstained. Motion carries.

**B.** Demoe & Menomonie St: Chair Jennifer Meyer explained to the Board where this parcel is. It is an all-wooded lot. Town would not have any use for this lot. Supervisor Paul Travis made a motion "Not" to approve the purchase of this parcel Supervisor Mona Mathews seconded the motion. All voted yes, motion carries.

### **Roads:**

**A.** Eau Claire County Highway Maintenance Agreement: Jon Johnson from Eau Claire County was at the meeting with a proposal. He is proposing to change the Eau Claire County Highway Maintenance Agreement to a fiscal year. Presently the contract runs from July 1<sup>st</sup> to June 30<sup>th</sup>. Town would have to add 6months to the contract to get to a fiscal year. Town has budgeted already for this year but with no big expenditures expected after this year, should be able to get through till December 31<sup>st</sup>.

Supervisor Mona Mathews made a motion to approve changing agreement to fiscal year. Chair Jennifer Meyer seconded the motion. She asked if there was any further discussion. Supervisor Jeff Bechard questioned if why the agreement was done July thru June? Supervisor Paul Travis questioned if it was because of winter plowing to get on one contract. Jon Johnson feels the reason, certainly be because of plowing, but no real reason why. Chair Jennifer Meyer asked for a vote from the board. All Town Board members voted yes To change the agreement to a fiscal year. Motion carries.

- **A.** Follow up: The Pines Music Park July 2 & 3/Performer Goose: Event was a success Large Assembly permit was paid. Supervisor Mona Mathews mentioned that she did Receive a call from a Town resident that the music was too loud. Resident said she did call Jim Bischel but that did not help.
- B. Amend Campground Large Assembly permit to include after event DJ in campground Country Jam July 15 – 17, 2021: This discussion started during the The Pine Music Park as residents complained it was too loud. Residents do not want music in the campgrounds late at night as it is too loud. Music in the Campgrounds during Country Jam is a DJ and the music should be able to be turned down but the residents don't have any numbers to call to tell them to turn it down and the Sheriff's department does not do anything with calls. Having the DJ in the campground was not listed on their original large assembly permit and that is the reason for discussion at this time. No one from Country Jam was at the meeting to answer questions. Residents would like music to stop earlier on Wednesday or no music at all on Wednesday.

Chair Jennifer Meyer made a motion to approve music in the campgrounds during Country Jam with the main change is that music on Wednesday night has to stop at 11pm. Supervisor Paul Travis seconded the motion.

Supervisor Mona Mathews voted Yes, Supervisor Jeff Whyte voted Yes, and Supervisor Jeff Bechard voted No. Motion carries on a majority vote.
