Board Meeting March 9, 2021

Roads:

A. Chayne Rd. Project Bid Awards/Cedar Corp: Cedar Corp was present at the meeting and mentioned that bids were opened on February 24, 2021. 8 Bids were received and the lowest was \$230K to \$340K. Low bid was from Stout in Chetek. Cedar Corp left a bid spec sheet will all bids listed. Cedar Corp has worked with Stout before and feel very confident with their level of work. Cedar Corp recommends having Stout do the Chayne Rd project. Town of Union will also receive the \$147k in grant money to help pay for this project.

Supervisor Mona Mathews made a motion to approve Stout bid at \$237,821.30 for Chayne Rd. Project. Supervisor Jeff Whyte seconded the motion. All voted yes, motion carries.

B. Xiong Blvd. pavement replacement BID Awards: Chair Jennifer Meyer, Supervisor Jeff Whyte, and Jon Johnson from Eau Claire County met on March 4th to open bids. 2 Bids were received, one from Senn Blacktop and the other from Monarch. Monarch was the lowest bid at \$76,945.00 and Jon Johnson from Eau Claire County recommends the Town award the bid to Monarch. There is a low area on Xiong that has to be bid separately to fix the soft spot first. Brent Wachsmuth

did give an estimate of \$6,650.00 to fix.

Supervisor Jeff Bechard made a motion to approve Monarch for work on Xiong Blvd. Supervisor Mona Mathews seconded the motion. All voted yes, motion carries.

C. Road Bans/weight limit begins 03/08/2021

D. Road Tour – Chair Jennifer Meyer and Supervisor Jeff Whyte will be done after frost is out of ground.

E. Any other road business: Silvermine will need some trenching done.

Visit Eau Claire:

A. Executive Director Benny Anderson: Benny Anderson handed out quarterly reports on room tax. Towns can report money lost from room tax due to Covid, Benny Anderson will keep the Town advised on how to apply. Room tax dollars have gone up as more people are traveling. Conservancy page on the website has seen a lot of traffic in the past months. Visit Eau Claire is still working on getting the trails map on a phone app. Also, will be working on looking at connecting all trails.

Park Commission:

Park Commission is working on getting brochures made that they can hand out and they are also looking at having a memorial area in the Conservancy. specs for Pavilion. Sherman Creek Park will be maintained the same as past years. Park Commission will have their finance report at the annual meeting.

C. Virtual WI Town's Assoc. workshop for Fire & EMT, Topics: Service requirements and funding options and volunteer recruitment & retention. Live or recorded March 12. Chair Jennifer Meyer mentioned to the Board that the Town of Union registered 3 people at a cost of \$30/each.
